## Tuition Payment Options

GRM charges a fixed monthly tuition for your child's regular schedule. We do not deduct tuition for school closings, scheduled breaks, sick days, vacation or other absences. Additional care will be billed separately from tuition payments. Several different tuition billing options are available for your convenience.

Please select which tuition payment option you are requesting by initialing next to your choice:

- 9 month billing cycle \_\_\_\_\_
  - tuition is due on the 1st business day of each month, beginning in September and ending in May
  
- 12 month billing cycle \_\_\_\_\_
  - student's 9 month tuition is divided between 12 months and is due on the 1st business day of each month, beginning in September and ending in August
  
- 9 Bi-monthly billing cycle \_\_\_\_\_
  - tuition is due on the 1st and 15th business day of each month, beginning in September and ending in May
  
- 12 Bi-monthly billing cycle \_\_\_\_\_
  - student's 9 month tuition is divided between 12 months and is due on the 1st and 15th business day of each month, beginning in September and ending in August
  
- One Installment Tuition \_\_\_\_\_
  - tuition that is to be paid in full for the upcoming school year is due the 1st business day in September, and will be at a 10% discount

## Tuition Payment Options

### Automatic Tuition Withdrawal Option:

I (we) hereby authorize Great River Montessori Inc. hereinafter called COMPANY, to initiate debit entries to my (our) **Checking/Savings** Account (circle one) indicated Debit Authorization Form at the depository financial institution named Debit Authorization Form, hereinafter called DEPOSITORY, and to debit the same to such account. I (we) acknowledge that the origination of ACH transactions to my (our) account must comply with the provisions of U.S. law.

### Check Payments:

If you would like to opt out of the automatic tuition agreement, a check may be made out to Great River Montessori. Tuition will be due on the specified agreement date selected above.

### Sibling Discounts:

Sibling Discounts will be applied as follows: first tuition (no discount); 2nd tuition (10% year's tuition); 3rd tuition (20% year's tuition); 4th tuition (30% year's tuition). No tuition refunds are offered for children's absences. Parents/Guardians are obligated to pay the entire annual tuition and applicable fees regardless of their choice in payment plan options.

### Delinquent Accounts:

A grace period of five days will be allowed. After this grace period, the account will be considered delinquent and the student(s) will not be allowed to attend GRM until all tuition is current. Additionally, a late fee of \$35 will be applied and a statement will be emailed. If an account is past due by 30 days, immediate payment will be expected. If full payment cannot be made, a payment plan not to exceed 60 days will be put into place and agreed upon by both parties. If contact and/or a payment plan cannot be worked out, at 60 days past due, the account will go to Small Claims Court and services by GRM will be terminated.
